

The Geoffrey Crawshay Memorial Travelling Scholarship

This Scholarship is provided from the income of a Memorial Fund raised by public subscription to perpetuate the memory of Captain Geoffrey Crawshay LLD.

- 1. UWRET will periodically award this scholarship to enable the successful candidate to travel in Britain or abroad with the intention of widening and enriching his/her aesthetic experience in a branch of the Fine Arts. The award is not to be used in the pursuance of study for a degree or diploma but for the encouragement of artistic practice and the cultivation of art appreciation; preference will be given to a candidate who shows outstanding ability in one of the Arts.
- 2. UWRET will take steps to publicise the Scholarship whenever sufficient money is available for the award to be made. UWRET, in deciding the amount to be awarded, will have regard to the expense likely to be incurred; it may be as much as £1500¹. UWRET may recommend making more than one award at the same time, provided there is sufficient money available; and, in very exceptional circumstances, may recommend an award exceeding £1500.
- 3. The Fine Arts which may be included under Regulation 1 will not be precisely defined, but they will include Music, Drama, Painting, Sculpture and Architecture.
- 4. Applications will be considered from the following persons:
 - (a) applicants who have studied for at least two years in a Welsh university;
 - (b) applicants who are able to show that they were born in Wales, or that they are of Welsh parentage or that they were educated in Wales, and who have studied for at least two years in the Royal College of Art, the Slade School of Art, the Royal College of Music, the Royal Academy of Music, the Royal Academy of Dramatic Art or such other institutions as may be approved by UWRET for the purpose of these regulations;
 - (c) applicants who have studied any of the subjects named in Regulation 3 for at least two years in a College or School of Art or Music or Drama or Architecture in Wales, approved by UWRET for the purpose of these regulations.
- 5. The application should give details of the applicant's eligibility, qualifications, training and experience, and of the use, if successful, to which the scholarship will be put. It should also state how long the proposed travel would be likely to take, and an estimate should be given of the expenditure involved. The names should be given of two persons who will be prepared to provide evidence about the applicant's fitness to receive the scholarship.
- 6. Recipients of the scholarship will be expected to submit a short report to the UWRET at the end of their tenure on the use made of it.
- 7. The Scholarship will be of the value of approximately £1,500 payable in two instalments. 75 % of the value of the Scholarship will be paid in advance, the remaining 25 % being paid upon submission of a satisfactory report by the holder.
- 8. No scholar shall, without the special permission of UWRET, hold during his/her tenure of the scholarship any other scholarship or similar emolument connected with any other university, college or public fund.
- 9. Applications shall be received by UWRET by 1 March², or other date announced from time to time.

These regulations are formed on the basis of the original bequest. When making an award, Trustees may apply discretion and interpret the bequest for modern times.

Any reference in these regulations to 'Welsh Universities' (or a 'Welsh university') shall mean former accredited institutions of the University of Wales or other Universities registered in Wales.

- 1. The actual value of the award will be subject to available funds.
